User Guide for Ex-ante Contributions Reporting

1. Glossary

Notion	Definition
S3	S3 – or “simple storage service” – is the object storage protocol (through a web service interface) used by the CSSF for the file exchange. In this context, S3 simply refers to the protocol for managing object storage and does not rely on any services provided by commercial cloud providers.
eDesk	The CSSF platform which allows professionals to carry out a range of procedures online.
EACIND	Ex-ante Contributions Reporting
EACRST	Restatement
SRB	Single Resolution Board
SRF	Single Resolution Fund
EBA	European Bank Authority
XBRL-XML	<i>eXtensible Business Reporting Language</i> The SRB requires this format for the Ex-ante contributions reporting from cycle 2023 onwards.

2. Introduction

Each year, pursuant to Article 70(2) of the Regulation (EU) No 806/2014, the Single Resolution Board ("SRB") collects data to determine the annual ex-ante contributions to be raised from the institutions within its scope.

Objectives of this document

This document is a guide that explains to the concerned entities how the ex-ante contributions have to be technically reported to the CSSF to comply with the circular CSSF-CODERES 26/22. Please note that the portal will be opened on 3 November 2026. Report should be submitted by 15 January 2027.

3. Reporting format

3.1 Data collection high-level process

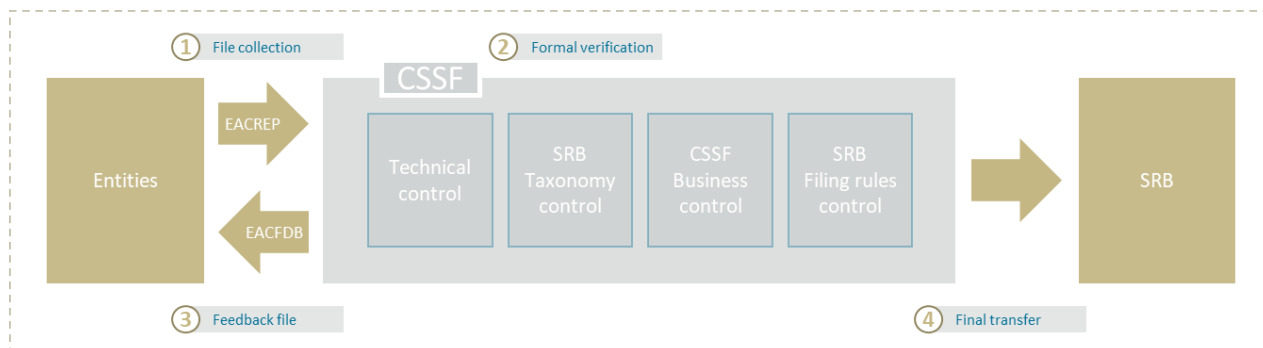
Data collection concerns both ex-ante contributions ("EACIND") and restatement reportings of previous collection cycle ("EACRST") that have to be transmitted in XBRL format.

Two distinct channels are at disposal:

- eDesk online portal - <https://edesk.apps.cssf.lu/>
- S3 system¹ - <https://www.cssf.lu/en/methods-of-transmitting-reports-via-api/>

The process for submitting a XBRL-XML EACIND reporting is the following:

1. File collection
2. Formal verification of the uploaded file
3. Feedback sending (positive or negative)
4. Final transfer to the SRB



3.2 XBRL general requirements

Data points covered by EU Regulations shall be reported in the XBRL-XML (eXtensible Business Reporting Language) format.

¹ Note that S3 simply refers to the protocol for managing object storage and not to any service provided by commercial cloud providers.

All XBRL instances to be sent to the CSSF must be fully compliant with the XBRL format defined by the SRB and must be transmitted via a compressed .zip format containing one single .xbrl file.

3.3 Naming convention

The mandatory file naming convention for .zip files is specified below regardless the chosen submission option (eDesk or S3).

4. Submission options

4.1 Report submission via eDesk portal

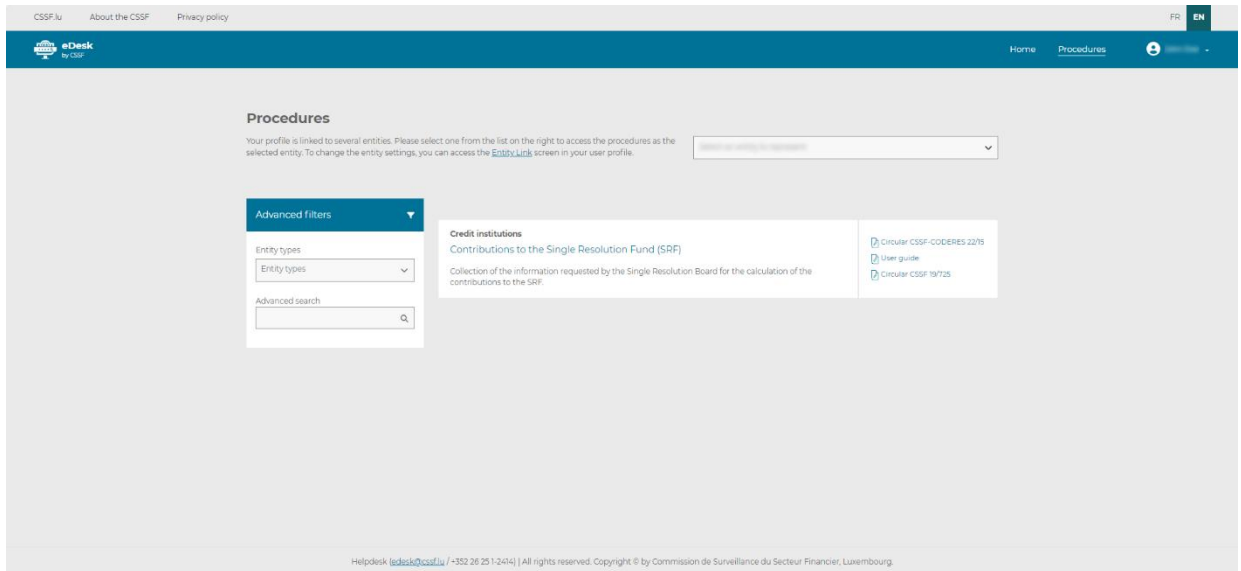
4.1.1 Authentication

The access to eDesk portal is made through a secured connection module after being authenticated. The prerequisites enabling connection to eDesk (activation of an entity link, validation of the needed roles by an advanced user, etc.) are detailed in the dedicated user guide which is available on the eDesk portal home page (<https://edesk.apps.cssf.lu/>).

4.1.2 Access to procedure

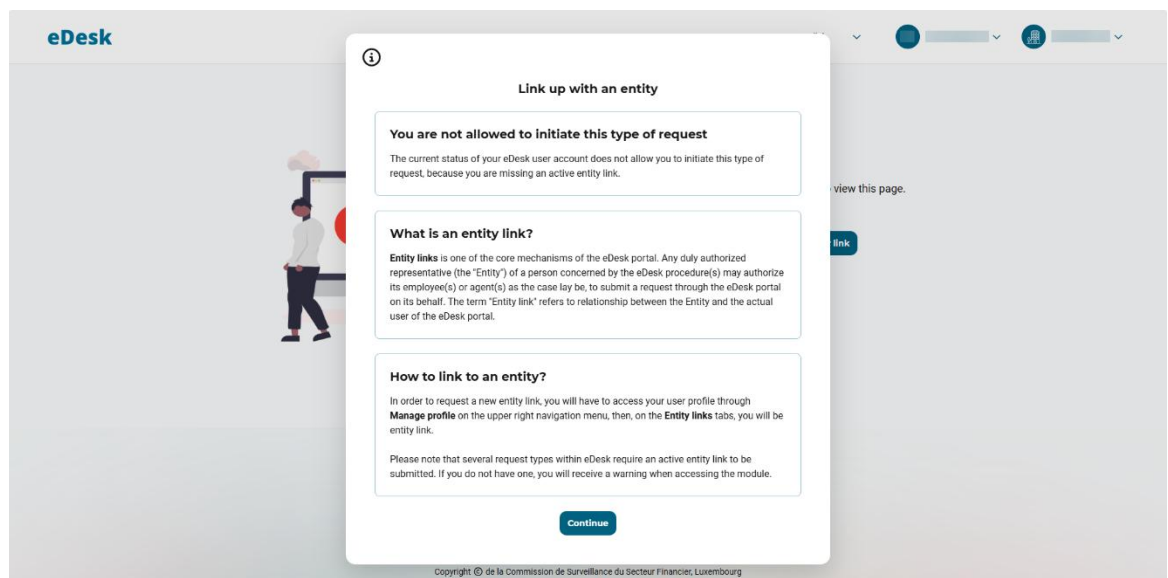
Once logged into eDesk, the "Contributions to the Single Resolution Fund (SRF)" procedure is available through the eDesk portal in the "Procedures" menu.



The “Contributions to the Single Resolution Fund (SRF)” procedure is accessible to anyone who has a valid “Entity link” granted by its entity’s “Advanced user” in eDesk.

All relevant information on how to request an entity link is available in the “eDesk - Authentication - User Guide” which is available on the eDesk portal home page (<https://edesk.apps.cssf.lu/>).

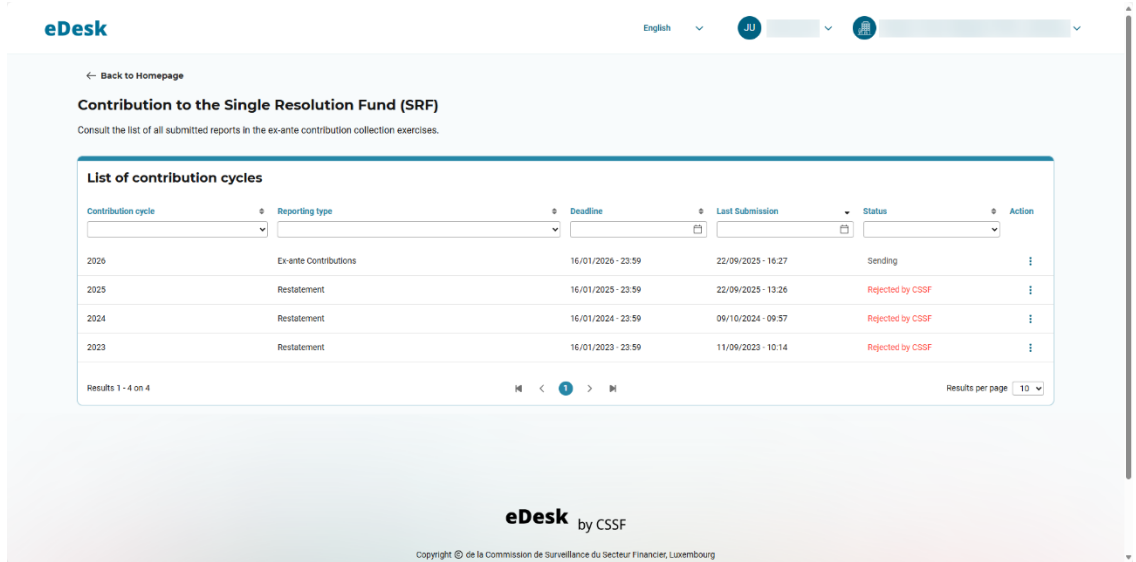
The screen below appears as a user is not linked to the relevant entity.



4.1.3 Dashboard details

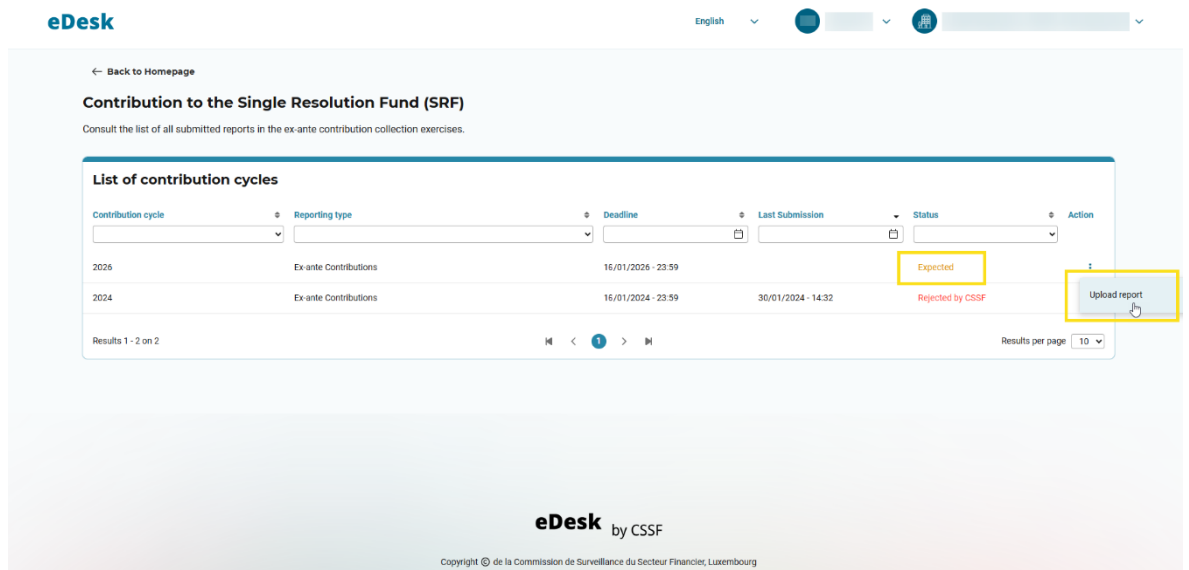

Each row concerns a year of contribution cycle. For one specific year, all submitted report versions can be consulted in the detail screen.

4.1.4 File upload

To upload a reporting file, there are two possibilities:

- For **expected reports** (each new contribution cycle), click on the "Upload" action and then select a ZIP file to transmit to the CSSF.

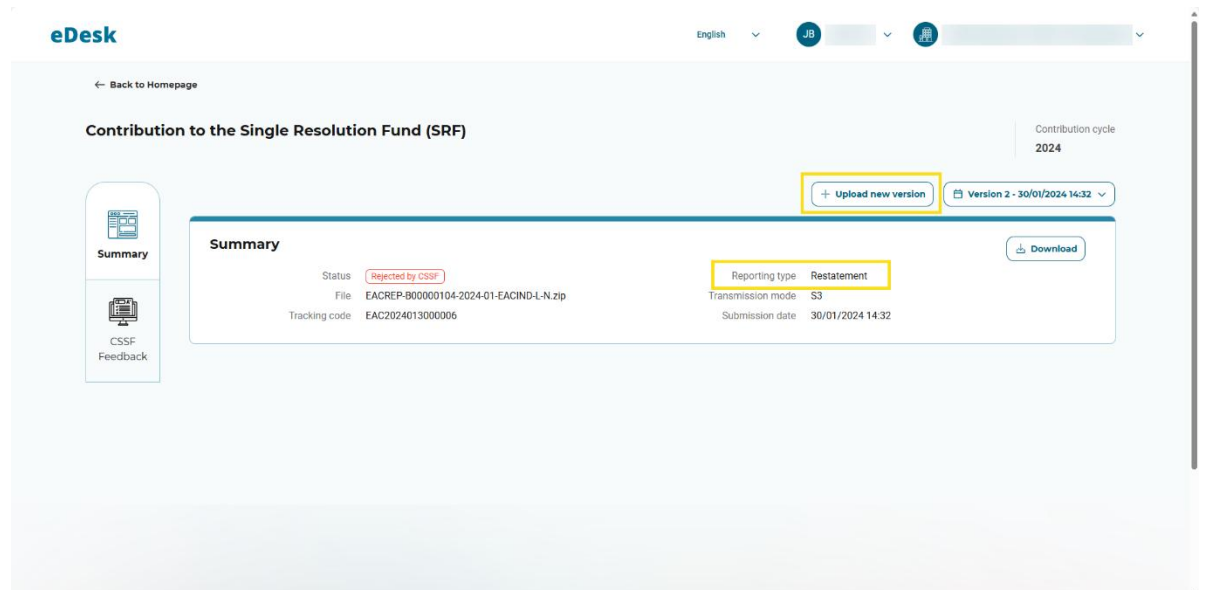

In eDesk, the intermediate status "Sending" indicates that transmission is in progress and that the validation rules are being applied.

If an upload is successful, the status of the file will be "Submitted to CSSF" or "Warning detected". If an upload is unsuccessful (CSSF feedback status = "Rejected by CSSF"), the file is not transmitted, and the user is prompted to repeat the upload after having consulted the feedback file.

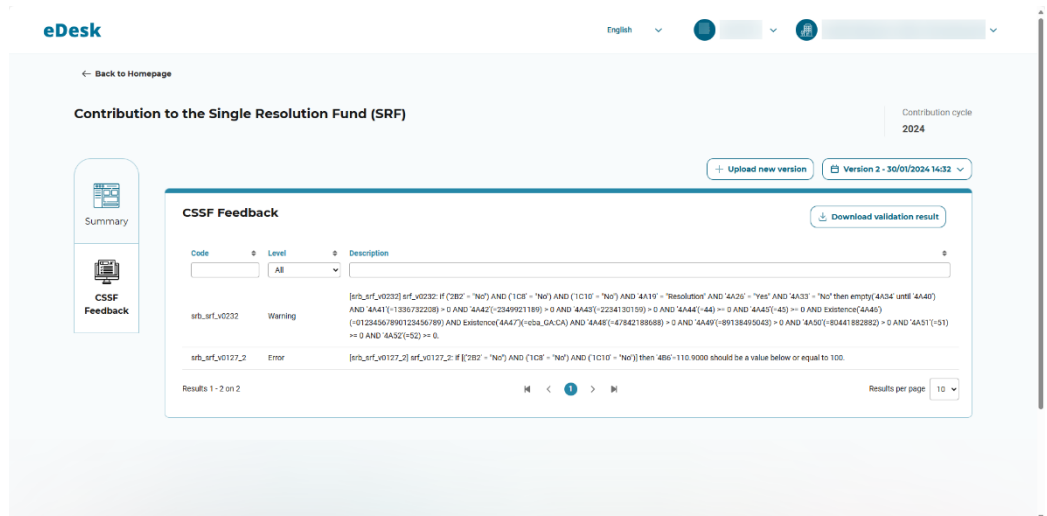
All the submitted versions for a contribution cycle are available through the versioning functionality in the detail screen.

4.1.5 Viewing and downloading feedback

The dashboard provides access to detailed feedback. CSSF feedback: generated right after uploading a report.

Feedbacks are either readable in the overview table or can be downloaded as a .CSV file.

4.2 Submission via S3 protocol

As soon as the S3 technical checks have been met, data submitted through S3 will be displayed in the eDesk portal.

5. Consistency verification rules

The CSSF will proceed to evaluate the submitted ZIP file which entails a series of formal verifications in order to ensure its compliance.

An indicative table of the rules to which a notification file may be subject is available in Annex 1: Formal verification rules.

The following controls are made:

- Technical control (nomenclature check, file validity)
- SRB Taxonomy control (validation rules and other taxonomy checks)
- CSSF Business control (coherence check with the former data reported to the CSSF)
- SRB Filing rules control (see more details in

- Annex 2: SRB filing rules)

6. Feedback file

It is up to the submitter to monitor transmission correctness.

A feedback file in CSV format is systematically generated for each file transmitted and made available in the "feedback" folder (in case of a submission via S3 protocol) or downloadable via the "Download" button (in case of a submission via eDesk portal).

Please ensure that you have the feedback file of the last file sent before submitting a new file. Feedback generation could take some time. In case of not receiving any feedback within a working day, please contact our dedicated support team (eacind@cssf.lu).

6.2 Report upload status

The file submitted might be either accepted by the CSSF or rejected.

All files that are submitted through S3 can be viewed in eDesk. On the other hand, files submitted via eDesk are not accessible in S3.

6.2.1 Upload status equal to 'Rejected by CSSF'

An upload status equal to 'Rejected by CSSF' means that at least one of the formal verification rules flagged as "Blocking" has not been met.

"Blocking" elements are flagged with an "Error level" equal to "ERROR" in the feedback file.

The feedback file provides further details.

The next step is to correct the concerned file and to upload a new one.

Example: EACFDB_EACREP-B00000XXX-2027-01-EACIND-L-N.zip_EAC20271512000001_Invalid.csv

6.2.2 Upload status equal to 'Submitted to CSSF' or 'Warning detected'

An upload status equal to "Submitted to CSSF" or "Warning detected" means that the file has been successfully transmitted to the CSSF.

However, non-blocking errors might rise in the feedback file. When the feedback status is "Warning detected", non-blocking elements are flagged with an "Error level" equal to "WARNING" in the feedback file.

The following message is available on the top row of the feedback file received after the submission of a valid file: "Your file has been successfully transmitted to the CSSF."

Example: EACFDB_EACREP-B00000XXX-2027-01-EACIND-L-N.zip_EAC20271512000001_Uploaded.csv

7. Transfer to the SRB

The CSSF is in charge to collect the reporting files and to upload them to the SRB portal. A valid file is thus expected at the identified deadline.

As the report is transmitted to the SRB by a CSSF agent, the status changes to 'Submitted to SRB'. This means that the report has been successfully transmitted to the SRB and is under review.

If the report sent to the SRB raises questions on their part, a CSSF agent changes the status of the report to 'Correction expected'. The next step is to correct the concerned file and to upload a new one.

8. Reporting entities obligations

8.1 Data quality

Entities are strongly advised to review and validate their ZIP file and its XBRL file before any submission.

Files must be validated against the XBRL schema provided by the SRB.

8.2 Review the feedback files and correct the rejected reports

Entities must ensure that all feedback files are properly analysed and that any rejected reports are corrected and resubmitted.

Annex 1: Formal verification rules

Controls at file uploading prevent undesirable documents from being transferred to SRB for various reasons:

Error Code	Explanation	Error level
EAC001	The file name does not respect the expected naming convention.	ERROR
EAC002	The file does not respect the authorised limit size.	ERROR
EAC003	The entity code mentioned in the filename does not match with the entity of the connected user.	ERROR
EAC005	The reporting type does not correspond to expected value 'EACIND'.	ERROR
EAC006	The accounting version does not correspond to the expected values 'L' or 'N'	ERROR
EAC007	An invalid file has been uploaded.	ERROR
EAC008	The uploaded ZIP file must contain one single XBRL file.	ERROR
EAC009	The decompressed file exceeds the authorised limit size.	ERROR
EAC010	The XBRL file name is not matching with the ZIP file name.	ERROR
EAC011	The CSSF is not expecting any Ex-ante contributions reporting at the moment.	ERROR
EAC012	The reporting type ("EACIND") does not correspond to the expected reporting date.	ERROR
EAC013	The reporting type ("EACRST") does not correspond to the expected reporting date.	ERROR
