We are pleased to enclose Commission Regulation (EC) No 342/2003 of 21 February 2003 and Commission Regulation (EC) No 350/2003 of 25 February 2003, amending for the twelfth and thirteenth time respectively Council Regulation (EC) No 881/2002 imposing certain specific restrictive measures directed against certain persons and entities associated with Usama bin Laden, the Al-Qaida network and the Taliban, and repealing Council Regulation (EC) No 467/2001.

These new Regulations amend Annexe I to Regulation (EC) No 881/2002 by adding one name under the heading of legal persons, groups and entities and one name under the heading of natural person, to whom the freezing of funds and economic resources applies as laid down in this Regulation.

Regulations (EC) No 342/2003 and (EC) No 350/2003 are binding in their entirety and directly applicable on the day of their publication in the Official Journal of the European Union (22 and 26 February 2003 respectively).
