Re: Identification and declaration of business relationships with terrorist circles

Ladies and Gentlemen,

We are pleased to inform you of the publication of Commission Regulation (EC) No 142/2006 of 26 January 2006 amending for the 62nd time Council Regulation (EC) No 881/2002 imposing certain specific restrictive measures directed against certain persons and entities associated with Usama bin Laden, the Al-Qaida network and the Taliban, and repealing Council Regulation (EC) No 467/2001.

The purpose of the new Regulation is to remove two entries from Annexe I to Regulation (EC) No 881/2002, which lists the persons to whom the freezing of funds and economic resources should apply.

Regulation (EC) No 142/2006 entered into force on the day following that of its publication in the Official Journal of the European Union No L 23 pages 55-56 of 27 January 2006. It is binding in its entirety and directly applicable in all Member States.
